Guidance for the reopening of school to Y10 and Y12 students

General guidance for students

- **Year 10** Students will be placed into 1 of 12 bubbles based on their house. They will remain in this bubble for the duration of the time they are in school. They will come into school once each week on a designated day:
 - o Tuesday: Starling & Taylor
 - o Thursday: Bryant & Morgan
 - o Friday: Evans & Rendall
- To avoid students travelling in during peak times we will be limiting the school day to:

Year 10: 10:00am - 1:00pmYear 12: 9:45am - 12:45pm

- For Y10 there will be three 1 hour sessions. Each session will be led by a different teacher in the following subjects: English, Maths, Biology, Chemistry, Physics and RS. This may not be their usual classroom teacher, though we have made every effort to maximise such matches.
- Sessions will support the work that has been set remotely (either current or past work) and will
 not cover new content. Students will still be expected to continue work on all assignments set
 remotely.
- **Year 12** will be placed in groups according to the two subjects in which they have indicated they would like face-to-face support. Timetable groups are W, X, Y and Z, you will be notified as to which group you are in and receive a timetable of lessons.
- Sessions will cover work from the year in preparation for the UCAS Exam (or to consolidate understanding for those not taking the exams).

All Students

- Students will not be expected to wear school uniform.
- Students must remain 2m from each other at all times, other than passing in corridors, or between desks in classrooms (which is considered low risk).
- On arrival students must go straight to their designated classroom (see timetable).
- Rooms A01, A03, A13 and A23 are accessible from the outside, entry and exit will be via these doors. All other rooms will be accessed by the main Atwell doors:
 - The main double doors are strictly for the use of the ground floor (A11 & A12).
 - The 2 fire doors are for the 1st floor (A21 & A22) and lower ground floor (A02) classrooms only.
- Students will remain in their classroom for the duration of the time that they are in school. They will be allowed breaks at their desks between lessons.

- Parents who drop students off must observe social distancing rules. No parent will be allowed
 onsite, including for drop off/pickup, unless they are collecting a child displaying COVID-19
 symptoms. Please try to avoid expecting the layby to be free, it would be helpful if parents could
 drop off in the surrounding streets and students walk to school.
- Where students must travel using public transport they should wear the correct PPE, details of which can be found here. Anyone doing so must store any PPE in a plastic container for the duration of the day, unless they choose to wear it in school.
- Students will be allowed to use the toilet at any point but must adhere to social distancing rules as displayed. The toilets in the basement of the Atwell will be the only toilets in operation for students. Toilets will be cleaned thoroughly each day and throughout the day.
- Each classroom will be cleaned thoroughly at the end of each day.
- Students will not have access to a school computer or Chromebook whilst at school due to the risk of cross-contamination. Therefore your son/daughter should come prepared and bring a device which can be connected to the school wifi for access to resources. There will not be access to power, therefore any devices brought in will need to be able to last the 3hr session without needing to be recharged. Students will not be allowed to use any school stationery or borrow stationery/equipment/devices from staff or classmates.
- Students will need to ensure they have sufficient water and a snack for the duration of the session as the water fountains will not be in use. There will not be any food or drink for sale in the school.
- Students are expected to behave in accordance with the 'Our Expectations' document, just as they would do on a normal school day. Any student failing to meet this expectation will not be allowed to return to site without permission.
- Should a student display COVID-19 symptoms whilst in school, they will immediately be put into isolation in A14. The member of staff currently responsible for them will notify reception, who will telephone parents to arrange collection. On arrival at the school the parent must telephone reception who will inform the student they may leave. Parents may use the lower car park behind the music block for this purpose only. Parents should arrange for a test ASAP and inform the school of the result of the test. Details on testing can be found here. The student should not return to school until they have had either a negative test or self-isolated for 14 days.
